

- Equity Oriented Schemes once again witnessed a drop in inflows although lesser than the previous month.
- The Average AUM increased by 0.2% to INR 7.68 Lakh Crs.
- Multicap Funds and Large Cap Funds saw the bulk of redemptions for the category whereas Focused Funds, Large & Mid Funds and Small Cap Funds saw positive inflows.
- In other Equity funds, Balanced and Dynamic category continued its heavy outflow.




 The contribution of systematic investment plans (SIPs) continued its decline to INR 7,788 Crs after record high of INR 8,640 Crs in March.



- Average AUM of Debt Fund decreased by 0.18% to INR 12.87 . Lakh Crs.
- Debt Funds faced heavy outflows to the tune of INR 52,000 . Crs in September almost entirely owing to redemptions in Liquid Funds.
- September saw good inflows into Banking & PSU, Floater and Short Term Fund categories.
- Liquid, Money Market and Ultra Short Duration Funds all faced outflows. Usually quarter end coupled with advance tax outgo does witness some outflows in the short duration.


