The Mutual Fund industry 's Avg. AUM increased by 3.36% to INR 34.10 Lakh Crs in June.

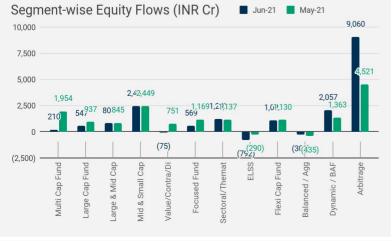
Hybrid schemes saw maximum inflows while FMPs saw considerable outflows.

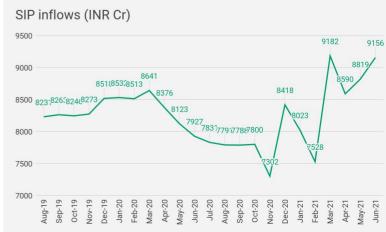

- Money Market Funds had maximum outflows in June followed by Ultra Short Duration funds, Short Duration funds, Gilt funds, Dynamic Bond funds, Gilt fund (10yr Dur.) and Long Duration funds.

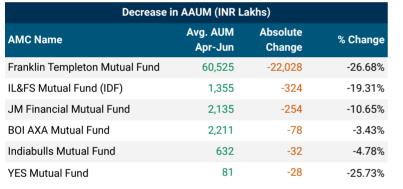
